FY 2012 Community Partnership Grant Final Budget

Reports Due Soon

Councils for International Visitors (CIVs) that received a FY 2012 Community Partnership Grant (CPG) and a FY 2012 Supplemental CPG are required to file final budget reports for both grants by **May 15, 2013**. Organizations that received both grants should be sure to include the combined total of the two grants on the final budget report.

The **FY 2012 CPG Final Budget Expense Report** form can be downloaded [here](#). You can save the downloaded report form in a Word document format. Completed forms can be uploaded to the [online grant site](#). Click Apply in the left margin and that will take you to the Application Status Page. Click on the blue text that says "FY 2012 Community Partnership Grant Final Budget Report" to proceed.
